Appropriate Use of Mobile Phones (and related technology) Policy

Policy

This document outlines the appropriate use of mobile phones and related technology for students, parents and community members whilst on our school site. On Thursday 13 December 2018, the NSW government announced that in response to the recommendations made by a review team the use of mobile devices during school hours will be restricted in NSW public primary schools.

Rationale

The staff of Roseville Public School recognise that in today's modern world, many students and their families own and regularly use mobile phones and related technology. We also recognise that some parents/carers may desire or need their child to have a mobile phone before or after school for various reasons.

Our school's core business of teaching and learning needs to be conducted in an environment free from unnecessary distractions or disruptions. This document outlines the appropriate use of mobile phones and related technology for students and parents/community members during school hours.

Purpose

The purpose of this policy is to ensure that:

- Mobile phones and related technology use does not disrupt the teaching and learning environment for any student or teacher;
- Potential risks to student safety and well-being posed by inappropriate use of mobile phones and related technology can be identified and addressed;
- Students and parents/community members have a clear understanding of school guidelines and personal responsibilities related to the appropriate use of mobile phones and related technology; and
- Students and parents/carers are aware of the appropriate channels for communication during the school day.

Responsibility

- Roseville Public School discourages students from bring mobile phones to school. However, where parents feel it is necessary for their child to have a phone in their possession at school, it is the responsibility of the student to abide by the appropriate use guidelines as outlined in this document.
- The decision to provide a mobile phone to their child should be made by parents or carers. They should be aware that their child is bringing a mobile phone to school.
- It is the responsibility of students and parents to comply with the guidelines outlined in this document and NSW Department of Education (DoE) policy.
- The school accepts no responsibility for lost, stolen or damaged mobile phones. This relates to phones at school or whilst travelling to or from school.

Related guidelines for Mobile Phones

- Mobile phones should be switched off as soon as students enter the school grounds. Phones must be turned off throughout the school day and must remain within school bags at all times. At the completion of the school day, students are permitted to use their mobile phone once they have left the school grounds.
- If students need to contact their parents during the day, the school's policy is that they do so through the school office.
- Mobile phones (and related technology including Smart Watches) are not permitted on school camps. All communication should be made via attending staff. Staff will be responsible for taking and distributing photographs whilst on camp.
- Parents/carers are reminded that in cases of emergency, or for any other communication that is necessary throughout the school day (such as changes to pick up routine) the school office remains the appropriate point of contact.

Sanctions

In line with our Student Welfare Policy, for students who fail to follow these guidelines, the following sanctions may be applied:

- Temporary confiscation of the mobile phone (handed back to the student at the end of the school day or parent contacted to collect the phone.)
- Communication with parents/carers regarding mobile phone use at school.
- A student's permission to bring a mobile phone to school being revoked.

Related Technology

- Smart Watches are often very useful for families after hours and are often used as a replacement for a mobile phone. Hence, they can be brought to school. However, during school hours they must remain within school bags or stored in the office.
- All other gaming and music related devices are not permitted.
- The school accepts no responsibility for the security of these items and reserves the right to determine if a device is appropriate or not.
- We define a Smart Watch as any device that has the **capacity** to connect to the internet or to be used for communication.

Exemptions

 Exemptions of this policy can only be approved by the Principal. Applications for exemption should only be requested due to exceptional circumstances and applied for through the school office to the Principal of Roseville Public School.

Implementation of this Policy

- This policy will be distributed to all parents/carers of Roseville Public School.
- Teachers will discuss this policy with students to ensure they have a clear understanding of the guidelines and procedures.

Ratification and Review

- This policy was last reviewed and ratified by the Roseville Public School executive staff in March 2023.
- It was forwarded to community at the same time.
- It will be reviewed again when deemed necessary by the school Principal.
